

## Introduction to the Field of International Relations

- Purpose of this Presentation
  - Introduction to how political scientists address the issue of sustainability

#### Introduction to the Field of International Relations

- Classical Theme in International Relations
  - How can we maintain peace?
  - Realists: "It is the balance of major powers that determine the stability in international order"
    - Emphasis on states as actors, and reality?
    - Exemplary theories: Balance of Power, Hegemonic Stability Theory
  - Liberals: "The free exercising of sovereign power should/ can be checked by rules and norms"
    - Emphasis on the diversity of actors (nexus of domestic and international arenas), and policies and ideals?
    - Exemplary theories: Dependency Theory, Democratic Peace Theory, Capitalist Theory

#### Introduction to the Field of International Relations

- **Realists:** "It is the balance of major powers that determine the stability in international order"
  - Regarding Sustainability: It can be considered under exceptional circumstances
    - They presume that it is only when realist mechanisms are taking a "break" that states can cooperate (Mearsheimer 2018)
    - Ex. Working towards sustainability under hegemonic stability

#### Classical Dichotomy of Realism and Liberalism

- Liberals: "The free exercising of sovereign power should/ can be checked by rules and norms"
  - Regarding Sustainability: They elaborate on the conditions for international cooperation
    - Whether it continues without the hegemon
    - Whether the relevant norms are internalized in member countries
  - Gave rise to neoliberal institutionalists and International Political Economy scholarship

  - Regime theories
  - Relation with hegemony
- International Political Economy (IPE)
  - Interaction with realism (hegemonic stability theory)
    - Power transition and international trade regimes
    - Relative capabilities matter

    - Lack of researchers at the Cross-Road of International Institutional Research and Comparative Politics/ Area Studies


Figure: The "erosion" of Discretionary Power of Sovereign States that Commit to International Institutions, figure by Tomoko Takahashi.



#### Narratives from both the international and Chinese levels (Takahashi 2019)

- Narrative on the International Level Narrative on the Chinese Level
  - Phase 1:
    - Utter need to protect the environment (beyond national jurisdiction), Vector 3
  - Phase 2:
    - Area-based management tools (ABMTs) become an issue, Clash of Vector 1 and
    - Marine genetic resources (MGRs) become an issue from Vector 1 (North-South divide)
  - Phase 3: Inevitable commitment to imposing policies on areas beyond national jurisdiction
    - Even Vector 3 focal points end up being fought over regarding Vector 1 and 2

- Phase 1:
  - Agreement with Vector 3
- Phase 2:
  - Agrees to an international jurisdiction regarding ABMTs, Push for Vector 2
  - Balancing between the North and the South regarding MGRs ("common wellbeing of mankind" (not "common heritage of mankind")
- Phase 3:
  - Accepting the usage of Vector 2 for the sake of national interest (maximization of national jurisdiction ≠ maximization of national interests)
    - ex. deep seabed exploration

## Conclusion

- The field of International Relations (IR) has been traditionally split into two groups
  - The divide was prominent regarding the feasibility of international cooperation
  - Recent scholarship (in international institutional studies that stem from IPE) emphasizes concrete hypotheses and their testing
- Case of BBNJ as a study that contributes to the maintenance of sustainability
  - Questions regarding commitment to international institutions as erosive factors for national jurisdiction
  - Inevitability of state-centric calculations on stakes  $\rightarrow$  Realism?

## Implications

- Latest researchers often lack a specific preference on the whereabouts of norm contents
  - Too much emphasis on dialogues in the "niche" theories and "robust" empirical analysis?
- Collaboration with public policy debates may be necessary to make a difference in real life
  - Assessment of regime complex situations etc.
  - However, we need to keep a "healthy" distance, not just towards governments but also toward international organizations
