• Revision of "Examples of related research content" for Basic Section (The current system of Basic Section, Medium-sized Section and Broad Section will be maintained, while the "Example of related research contents" of Basic Sections have been revised.)

• Implementation of joint reviews in multiple Basic Sections for "Scientific <u>Research(B)"</u>

(In the "Scientific Research(B)" category, for some Basic Sections where the number of applications is significantly low, a joint review will be carried out by multiple Basic Sections.)

(3) Relaxation of Restriction on Parallel Grant Application/Receipt on Early-Career Scientists (second application) and Challenging Research (Pioneering)

OFrom the FY2023 call, restriction on parallel grant application/receipt for Early-Career Scientist(second application) and Challenging Research (Pioneering) will be relaxed in order to further improve support for young researchers. (Please refer to the FY2023 guidelines for the relevant categories (the call is scheduled to open in early August 2022))
